## Covid-19 and Roundup

An immuno-compromised marriage in hell By Mischa Popoff

The war is on! A crucial weapon in the attack is the recent advent of Roundup (glyphosate) showing up in our food.

This widely-used herbicide is showing up in our food because it's being used for something for which there was never any long-term safety-testing: the forced ripening of crops called **desiccation**, a highly questionable agronomic practice<sup>i</sup> which contributes to the **suppression of our immune systems**.<sup>ii</sup>

Roundup works by poisoning the *shikimate* pathway, hindering photosynthesis. Since humans and animals don't rely on photosynthesis, we were always assured by regulators and manufacturers alike that we could safely consume Roundup. But we now know our bodies rely on trillions of microorganisms that **DO** rely on the *shikimate* pathway, like bacteria that are integral to our immune systems.

Ignoring this, Bayer execs seek to dominate the fast-growing **desiccation market** with their recent purchase of Monsanto. Just one problem, Bayer is being sued by thousands of people who claim to have contracted cancer from **applying** Roundup.

Strangely, none of these 40,000+ Roundup lawsuits are from consumers who have inadvertently **consumed** Roundup. Why?

- Because it's next to impossible to clinically prove how one's God-given immune system
  may have been impacted as long as conventional, centralized medicine prescribes
  patented, pharmaceutical vaccinations as the ONLY mean to maintaining "herd immunity"
  on a disease-by-disease basis, instead of boosting overall health.
- And, as mentioned, since it used to be effectively impossible for us to even inadvertently consume Roundup, the government has never required any long-term safety testing.
- As such, Food Giants like General Mills which make use of massive volumes of desiccated grains in their products have skirted or won the few lawsuits thrown at them.
- Don't bother looking, and you won't find bad news, is the maxim being applied.

Bayer has not been as fortunate as General Mills. And yet, and again, strangely, none of the settlements against Bayer have to-date been for farmers. Wouldn't farmers be **the first** to succumb to illness if Roundup (glyphosate) was a carcinogen?

One could conclude the Roundup lawsuits against Bayer are a **diversionary tactic** in this battle, and that Bayer executives may in fact welcome these lawsuits as long as no one figures out that the **real** problem with Roundup isn't with people **APPLYING** it; it's with people **EATING** it.

Anyone who believes for a second that Werner Baumann, the CEO of Bayer, made a mistake when he signed the deal to buy Monsanto, doesn't understand globalism. To say nothing of the crucial role Roundup is potentially playing in the **Covid-19** "pandemic" through immune suppression, and how **Covid-19** is itself playing into the larger globalist agenda.

The plan is for Bayer to become **indemnified** against any future claims of injury from citizens whether they **apply** or **consume** Roundup,

- just as vaccine companies were indemnified by President Reagan in the 1980's,
- just as Big Tobacco was indemnified in the 1990's by President Clinton.

In both cases, all future liabilities were passed on to We the People, while the mounting cost of regulatory compliance, a direct consequence of the legal process, resulted in monopoly control.

In Bayer's case, off-brand makers of glyphosate (generic Roundup) will be swallowed up or driven out of business as a thicket of new "safety" regulations are implemented surrounding the manufacture and use of Roundup, eventually leaving only Bayer standing as the global supplier of this herbicide that corporate farmers can't live without.

Meanwhile, the allowable "safe" limits for **ingesting** Roundup were based on standard LD50 testing (Lethal Dose 50% in lab animals). These were toxicological tests, **not immunological!** No one has ever tested how Roundup impacts our immune systems that are teaming with bacteria which ARE adversely impacted by Roundup through interruption of the *shikimate* pathway. And if Bayer gets their way with the regulators, no one ever will.

- Have you noticed no one argues any longer about whether smoking causes cancer?
- ... and that it's impossible to sue a pharmaceutical corporation for injuries caused by vaccines?

Admitting the problem only granted license to perpetuate the problem... legally, with a big-fat regulatory stamp of approval from the federal government that only the biggest corporations can afford to comply with, a regulatory framework these very-same corporations helped write and get passed through Congress.

And so, just when you thought you'd had enough of all the disinformation from the CDC, NIH and WHO on this **Covid-19** pandemic, it now behooves you as a free-thinking citizen to include consideration of your friendly-neighborhood USDA, EPA and FDA. And don't forget the FCC. Consider that...

- We're already being subjected to mass vaccinations which many say are ineffective and in fact suppress overall immunity,
- Forced Covid-19 vaccinations are sure to come,
- Then there's the fast-tracked roll-out of 5G (FCC)... what's the rush?
- Combined with martial law ("shelter in place" and "social distancing")
- And the shutting down of small businesses, churches and schools.

Now add to this list further <u>immune suppression</u> with Roundup, which is where the USDA, EPA and FDA enter the picture by greenlighting the highly dubious practice of crop desiccation.

Besides the potential health impact, the overuse and misuse of Roundup has been contributing to the final destruction of the family farm for years now. **Desiccation** with Roundup allows for fewer, low-skilled laborers to harvest much larger tracts of land, with dwindling profit margins, resulting in the long-anticipated move to total corporate control over food production. Remember what Kissinger said about food?

- Now add to this the slow poisoning of the population with unknown results:
  - As long as regulators don't bother looking into the immunological impact of Roundup, they won't ever find it! Guaranteed.
- Add to this the depletion of micronutrients and minerals in our soils, AND the destruction
  of soil microbes (without which there is no soil) by the ongoing expansion of industrial
  farming, and you get foods referred to as "empty nutrition." (Rudolf Steiner)

The result will be a diminished, docile, slave population to do the elite's bidding, all while Bayer makes a killing by charging farmers whatever they want for a gallon of Roundup in order to offset their legal liabilities, driving up the cost of food.

Adding insult to injury, Baumann is pretending he couldn't possibly have **imagined** the Roundup lawsuits would get this bad (40,000 cases, some say as high as 100,000) and has forestalled settlement negotiations with plaintiff lawyers, blaming the Covid-19 epidemic for making it impossible, "to meet in person for talks." Hasn't he heard of teleconferencing? Baumann's imagination seems to be functioning just fine. And remember the "failure of imagination" we were told prevented intelligence agencies from foreseeing 9-11? Don't fall for it again.

Baumann, his phalanx of lawyers, accountants and other advisors, right alongside his creditors, their phalanx of lawyers and accountants, AND their ratings agencies and insurers... all knew EXACTLY what they were getting into when Bayer bought Monsanto. He's playing the role of the victim... but would better be described as the cat who ate the canary.
